AUTHORIZED TACORI RETAILER'S SIGNATURE ON THE ORDER FORM INDICATES THAT ALL SELECTIONS ARE CORRECT AS WELL AS ACCEPTANCE OF THE TERMS AND CONDITIONS ("TERMS") THAT FOLLOW.
